Member McCaulley moved to approve the minutes of the November 18, 2025, meeting; the motion was seconded by Member Lunsford; the motion was adopted, 3-0.

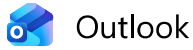

### **Re: Naming of a Municipal Facility within the newly built City Hall or an eligible street within city limits**

Dear Mayor Rick Helton, City Manager Corby Alexander, and City Council Members,

We, the family of Doris Pauline Lewis, respectfully submit this formal request for consideration to name a municipal facility within the newly constructed City Hall and/or a street within the City of La Porte in her honor. This request is made pursuant to the City of La Porte Code of Ordinances, Article I, Section 2 1, which governs the naming of municipal facilities in recognition of individuals who have made significant and enduring contributions to the community.

Ms. Pauline Lewis affectionately known as “The Godmother of the Northside” was a lifelong resident of La Porte, Texas, whose service, and dedication profoundly shaped the entire community. Born in September 1926 to Richard and Arilla Glover, she was educated locally at the historic “Colored School,” reflecting both her personal legacy and the broader historical journey of the city. Ms. Lewis devoted her life to service, leadership, and civic responsibility, embodying the very values the City’s naming policy seeks to honor. While this beloved title reflects the deep impact she had within her immediate neighborhood, we do not wish to minimize her service as being limited solely to the Northside of town, as Ms. Pauline made a meaningful and lasting impact throughout the entire City of La Porte.

Continuing her legacy of service and commitment to education, the Lewis family has provided scholarships to students graduating from La Porte High School, ensuring that Ms. Pauline’s dedication to uplifting future generations lives on.

#### **Alignment with City Naming Policy:**

In accordance with Section 2 1(c)(3) of the City’s Code of Ordinances, municipal facilities may be named in honor of deceased local community leaders who have provided outstanding personal service resulting in a significant and enduring contribution to the community. Ms. Pauline Lewis meets and exceeds this criterion.

Her contributions include, but are not limited to, the following:

**Extensive Community Volunteerism:** From the early through late 1980s, Ms. Lewis volunteered extensively with local schools and Neighborhood Centers, dedicating countless hours to supporting families, youth, and underserved populations throughout La Porte.

Humanitarian Service and Personal Sacrifice: Ms. Pauline Lewis was known for opening the doors of her home to individuals and families in need across the city, providing shelter, comfort, and a sense of belonging during difficult times.

Humanitarian Recognition: In February 1988, she was honored with the Gus Gross Humanitarian Award and named Volunteer of the Year, acknowledging her exceptional commitment to helping others.

Civic Engagement: Ms. Lewis served for many years as an election judge, demonstrating integrity, leadership, and dedication to the democratic process. Her service influenced community members, voters, and public officials alike.

Formal Recognition by the City: On June 21, 1991, Mayor Malone and the La Porte Independent School District proclaimed Pauline Lewis Appreciation Day, recognizing her outstanding service and lasting impact on the community.

Cultural and Historical Contributions: In 1997, Ms. Lewis received an award from the Black History Committee honoring her significant contributions and enduring legacy within La Porte.

Faith and Organizational Leadership: She faithfully served as secretary of Zion Hill Baptist Church for many years and was a long-standing member of the Order of the Eastern Star, continuing her tradition of mentorship, service, and community support through faith-based and civic organizations.

### **Request for Consideration**

In light of these contributions and in compliance with the City's established procedures, we respectfully request that the City consider naming a municipal facility particularly within the newly built City Hall or an eligible street within city limits in honor of Ms. Pauline Lewis. We understand that such requests are subject to review by the City Manager's Office, the City Facilities Naming Committee, and final consideration by the City Council, and we are prepared to comply fully with all application requirements, supporting documentation, and procedural guidelines.

Ms. Pauline Lewis's life of service represents the character, history, and spirit of La Porte. Naming a municipal facility or street in her honor would serve not only as a tribute to her legacy but also as an enduring reminder to future generations of the value of civic engagement, compassion, and community leadership.



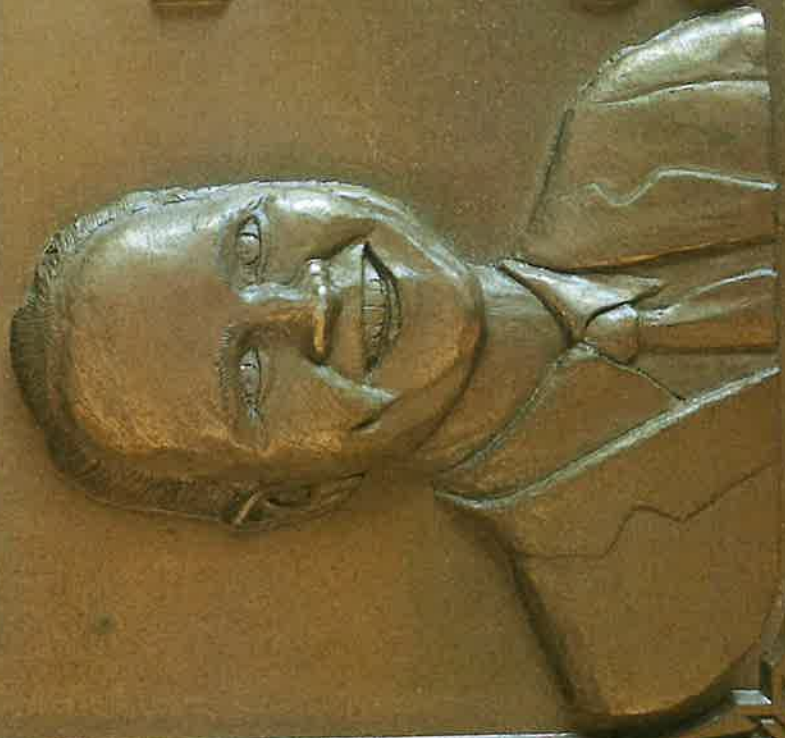

The festival activities and entertainment will bring excitement and lots of fun. The public is more than invited to join in, Gay said.

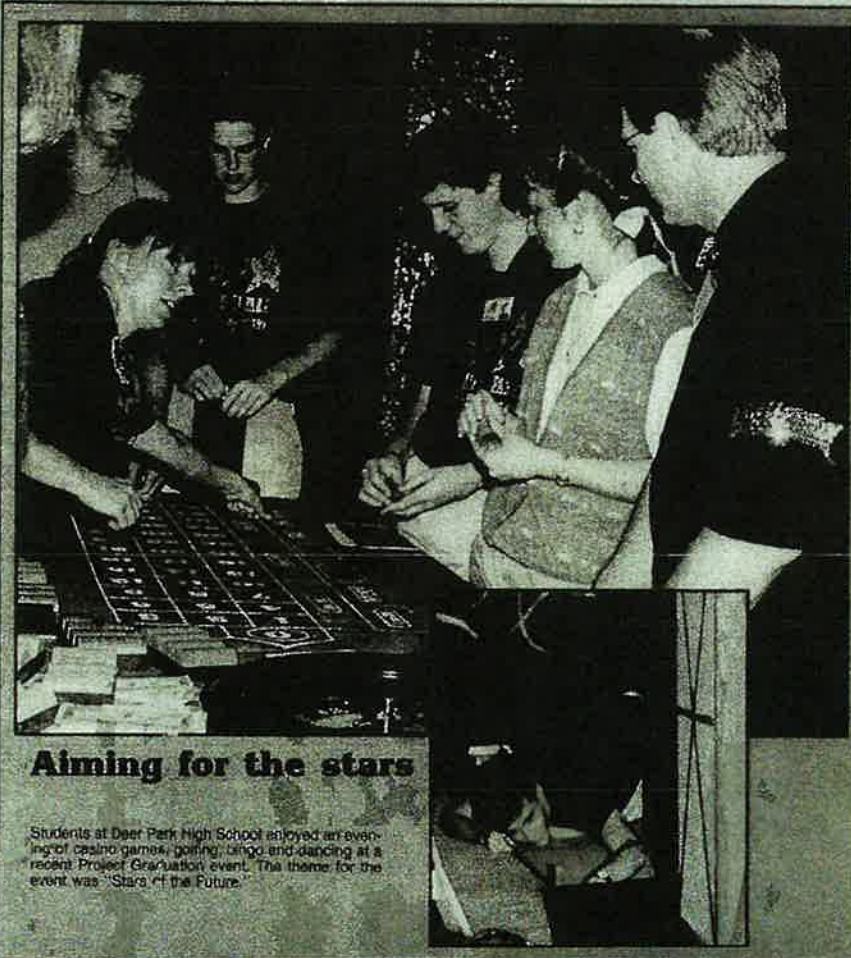

## La Porte volunteer sees charity pay off at home

Pauline Lewis noticed that her cabinet doors were falling down.

So the 74-year-old volunteer at La Porte's Neighborhood Center asked if someone could fix them.

Fix them they did. As part of H.B. Zachry's community service projects, the Pasadena company has given Lewis' home a complete face lift.

The extensive repairs, which are valued at \$10,000, were triggered by Zachry employees' visit to Lewis' La Porte home.

"Her daughter had had a kidney transplant, and she was really in bad shape financially," said Jane Roberson, co-chairwoman of Zachry's community service projects. "We found boards on the outside rotted and water standing. We found holes in the walls

from mice, and the floor under her washing machine was nearly gone. She had almost no linoleum on the floor left, and her roof leaked.

With the help of donations from neighborhood businesses, approximately 50 Zachry employees volunteered their time to refurbish the dilapidated house.

"We started on the 18th, and as many people as we could get together went back in the evenings. The work was completed last Saturday (June 25)," said Debbie Green, who co-chairs the community service committee with Roberson.

A&E Carpeting in La Porte donated three rooms of carpeting, and Anchor Furnigation in La Porte sprayed the house for termites.

and roaches.

Chem-Fly Services knocked off old paint in preparation for the volunteers to paint the house with supplies sold at cost by Furrow Building Materials in Pasadena.

Exposed wires were replaced, new receptacles were installed and hand rails were built on Lewis' front and back porches.

"She can barely walk," Roberson said. "She was using an old stick to help her walk, and one of our workers who makes canes for a hobby made her one. Now she can walk."

Lewis is no stranger to volunteer work, having been a volunteer since the early 1950s.

"She started here in 1952 when we opened," said Sue Skinner, manager of the Neighborhood Centers La Porte/Bayshore. "She delivers day-old bread and helps with special events like Christmas projects and the School Shoes Project. She is a sweetie.

"She is very involved with other volunteer organizations like the La Porte Community Civic Association and the Volunteer Support League."

Lewis wasn't home to see the volunteer efforts at her own home. She had suffered a heart attack on June 7 and was in the hospital when the

repair project began.

She has since returned to much more livable quarters.

"I was surprised," Lewis said. "I got a big, white house inside and out — and so many other things they did. I came home from the hospital Friday (June 24), but I had to stay at my daughter's because they were working."

Did the repairs seem like compensation for Lewis' years of volunteer efforts?

"It pays off," she said. "That was a nice gift — I'm telling you. I just wonder what can I do for them? Just to say 'thank you' is so little, so darn little. But I'm saying it from my heart."
