SUMMARY & RECOMMENDATION

The Dangerous Building Inspection Board is composed of the Chief Building Official or their duly authorized representative, the Fire Chief or their duly authorized representative, and the Fire Marshal or their duly authorized representative, as established by Sec. 82-472 in the Code of Ordinances of the City of La Porte.

On March 25, 2024, the Board submitted ten (10) structures to the City Council. The Board identified these ten (10) structures as dangerous or substandard, as described in Sec. 82-473 of the City's Code of Ordinances. For the six (6) structures located at 114 S. lowa St., 209 S. Carroll St., 210 S. lowa St., 601 S. Carroll St., 9404 Carlow Ln., 9406 Carlow Ln., Council motioned to postpone consideration for ninety (90) days and directed staff to provide an update after ninety (90) days on the status of the structures.

Attached are the inspection results for the structure located at 601 S. Carroll St. The property owner has contacted staff and is in the process of cleaning out the property to put it up for sale.

Per Sec. 82-478 of the City of La Porte Code of Ordinances, "...the city council should make its decision in writing setting out the facts upon which it based its opinion. If its decision is in favor of the findings of the board to the effect that the building is in fact a dangerous building and is a nuisance and a hazard and that it is, by such order, condemned. The order shall further require, as the facts may justify, that the owner shall either repair such building in compliance with the building code of the city, or that the owner shall entirely remove or tear down such building, and such repairs or removal shall be commenced within ten days from the date of such order and be completed within a reasonable time."

Staff finds that the public hearing notification requirements outlined in Sec. 82-475 were performed in accordance with code provisions, including the following: "...the notice shall be published in some daily newspaper of general circulation in the county, two times. The

first publication shall be inserted not more than 15 days and not less than ten days prior to the date of the hearing provided for in this article, and the last publication shall be not more than ten days and not less than three days prior to such hearing." Written notice was also given by registered mail, with return receipt requested, addressed to the last known address of the owner. In accordance with state law, notice of the public hearing was also posted at City Hall and on the City's website. Staff mailed certified letters with this information to the property owners of record, posted on the properties, and posted in the Bay Area Observer.

The Board recommends that the City Council consider the findings and order the repair or demolition of the buildings or structures determined to be dangerous or substandard.

Economic Development. The City of La Porte will promote a strong and diverse economy that strengthens the local sales tax and property tax base while also contributing to a high quality of life. Planning will work to improve the city by removing substandard structures as part of this goal.

ACTION REQUIRED BY CITY COUNCIL

The City Council will hold a public hearing followed by discussion, consideration, and possible action to adopt Ordinance 2024-3977 ordering the condemnation of dangerous/substandard structures located at 601 S. Carroll St., La Porte, Texas. [Curtis Tarver, Deputy Building Official]
