## **SUMMARY & RECOMMENDATION**

The City of La Porte City Council adopted the Fiscal Year 2023-24 Budget on September 25, 2023. Due to a grave public necessity and to meet an unusual and unforeseen condition that could not have been included in the original budget, staff has requested a budget amendment of \$575,000.00 for repairs to the Sylvan Beach Pier for damages sustained from Hurricane Beryl. The funding will come from an escrow account established by the City and Harris County for the future repairs and restoration of the pier in the event of damage or destruction to the pier.

The Summary of Funds, which is shown below, represents the original adopted budget, and the amendments that Council previously approved to the FY 2023-24 Budget. (\*denotes funds with current changes)
